We are actively investing in solar projects and are seeking partners with access to existing or new project opportunities who can benefit from our access to capital and financial expertise.

solar projects we seek to invest in

- Small-scale and medium-scale embedded generation projects which are either grid-tied or in a hybrid system (batteries / generators). This will range from project sizes of IOOKW (c. RIm) up to 25MW (c. R350m).
- Underpinned by Power Purchase Agreements ("PPAs") and / or operating leases with a focus on commercial, industrial, agricultural and body corporate off-takers.
- Existing and new solar PV projects
- Grid-tied and hybrid systems (generators and/or batteries)

Exclusions include residential solar projects which don't qualify for the Section 12B incentive and government off-takers.
