fund overview

Westbrooke Yield Plus Plc (the Fund) is an open-ended Jersey Expert Fund which provides investors with a high-yielding, fixed income alternative investment, through a diversified portfolio of approximately 50 predominantly floating rate private debt transactions mainly in the UK, with a total gross asset value of GBP176 million.

The Fund provides a unique investment advantage driven by an asymmetric risk / return profile, which is achieved by providing loans to lower and middle-market UK companies and real estate sponsors, a significantly underserved UK market segment. In the context of a high-interest rate environment, this allows investors to benefit from a target annual return of cash* plus 4% - 6% per annum (currently 7%-9% p.a. on a run rate basis) in GBP (after fees and costs).

Capital preservation is core to the Fund's investment philosophy, with approximately 80% of the Fund's loan exposures benefiting from senior ranking security. This security typically takes the form of real estate and/or tangible assets (c. 81% of the Fund) at a conservative average loan to the value of approximately 57%.
